WHO CAN BE NOMINATED?

- *Nominees must currently work at a secular business or organization (not a parish, Catholic school or other Catholic institution) within the Archdiocese of Saint Paul & Minneapolis*

- *Nominees must currently live within the Archdiocese of Saint Paul & Minneapolis and be a member of one its parishes.*

- *Nominees must hold an explicit position of leadership and authority within the business and lead a team of people, whether that team be a department or an entire company.*

e.g. owner, president, vice president, director, manager, supervisor, etc.

- *Nominees must lead with their Catholic faith in the workplace. Their workplace demeanor, behavior, actions, and leadership style must bear witness to Jesus Christ and His Church.*

WHAT MAKES FOR A GOOD NOMINATION FORM?

WHAT IS THE SELECTION COMMITTEE LOOKING FOR?

The main question the selection committee is trying to answer is this:

“How does this nominee lead with their Catholic faith in the workplace – witnessing to Jesus Christ through his/her demeanor, behavior, actions, and leadership – in an exemplary manner?”

As a nominator, it is your responsibility to answer this question for the selection committee who, unlike you, (probably) does not know anything about the person you are nominating. This nomination form is your opportunity to provide the selection committee with an impression of who your nominee is.

A good nomination form does this by:

- Answering each question thoughtfully and as asked.
- Using anecdotes and specific examples within answers.
- Asking others (employees, coworkers, clients) who are familiar with the nominee in their place of work for specific examples and including them into your answers as well.

Q5 Name 1–3 virtues that the nominee possesses to a notable degree. How are these virtues embodied and revealed throughout his/her daily work?
